Members' Remuneration Ordinance 2009 *section 8*

Amounts paid to and in respect of Members - year ended 31 December 2025

1. Section 8(1) of the Members' Remuneration Ordinance 2009 requires the Clerk of the Assembly to publish the following information:-
 - (a) the amounts paid to each Member during that year, as an annual salary under paragraph 3 of the Schedule;
 - (b) the amounts deducted from the payments made to each Member during that year in accordance with:-
 - (i) section 23 of the Medical Services Tax Ordinance 2010;
 - (ii) section 14 of the Retirement Pensions Ordinance 1996;
 - (iii) section 18B of the Falkland Islands Pensions Scheme Ordinance 1997; and
 - (iv) regulation 8 of the Payments on Account of Tax (Employees' Deductions) Regulations 1997;
 - (c) the amounts paid in respect of each Member in accordance with section 11 of the Retirement Pensions Ordinance 1996;
 - (d) the amounts contributed to the Falkland Islands Pensions Scheme in respect of each Member in accordance with section 18 of the Falkland Islands Pensions Scheme Ordinance 1997;
 - (e) the amounts paid to each Member in respect of expenses claimed under the Schedule; and
 - (f) a detailed breakdown of the amounts paid to each Member in respect of such expenses.
2. Section 8(2) of the Members' Remuneration Ordinance 2009 requires the Clerk of the Assembly to publish the information listed above in the *Gazette*. The following tables published in this *Extraordinary Gazette* provide information for the year ended 31 December 2025.
